### **RELEASE AND HOLD HARMLESS AGREEMENT READ CAREFULLY BEFORE SIGNING**

A. Student has been informed and understands that this contract relates to his/her role as a participant in the Karate Program offered by Stephen Ciriaco at the Plantation Community Center.

B. Student has been informed and understands that the above Karate Program is considered a contact sport.

C. Student has been informed and understands that he/she may expect physical contact through his/her voluntary participation in the above Karate Program.

D. Student has been informed and understands that this contract is a complete waiver of his/her right to be free from those bodily contacts that are inherent within his/her voluntary participation in the above Karate Program.

E. Student freely assumes the risk of injury to himself/herself in connection with participation in the above Karate Program.

F. Student is aware and recognizes herein that he/she will be confronting and expressly assuming the dangers and risk of bodily harm which are inherent within participation in the above Karate Program and that any and all injuries which may result therefrom are foreseeable.

G. Student has been informed and understands that Stephen Ciriaco does not carry insurance, either medical or otherwise and that any coverage desired is solely the Student's own responsibility.

H. Student further understands and agrees that although he/she may become injured while following the order or directive of Stephen Ciriaco or any other person that he/she is knowingly, willingly and voluntarily assuming any and all risk resulting therefrom.

I. In consideration of the right to participate in the Stephen Ciriaco Karate Program and for other valuable consideration received Student agrees to release, hold harmless and agrees not to sue Stephen Ciriaco for any and all claims or losses occurring in connection with his/her voluntary participation in the Karate Program.

J. This release includes any and all claims and/or losses occurring due to any cause including, but not limited to the negligence, active or passive, of Stephen Ciriaco and/or any other person.

The Student agrees that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida. The Student states that he/she has carefully read this agreement, knows its contents, and signs the agreement of his/her own free will and accord. The terms of this agreement are contractual and not a mere recital.
